• CSUN Audit Requirements:

o A comprehensive list of all applications and services maintained exclusively by each department should be documented within continuity plans on VEOCI.

- Detailed document outlining equipment necessary to restore each application/service during disruptions.
- o Documented recovery processes for each application/service, including dependencies such as campus authentication protocols.
- Schedule indicating past and future testing of recovery processes to validate effectiveness and identify improvement areas.

• Discussion:

CSUN uses the Veoci platform for Business Continuity storage, but other auxiliary schools have not heard about Veoci.

- Need for a centralized repository for:
